### Changes to LPI fees as a result of the November 2008 Mini-Budget

The Department of Lands is officially registered in the Australian Business Register and also registered for GST. Its ABN is 21 804 973 362

In the Mini-Budget released by the Government on 11 November 2008, it was announced that LPI lodgment fees for property transfers will increase from \$92.00 to \$184.00 from 1 January 2009.

#### What does 'property transfer' mean?

A property transfer is defined as a dealing that changes the ownership of an estate in land under the *Real Property Act 1900*.

#### Will the increased fee apply to all property transfers?

No. The fee increase will apply only to transfers that change the ownership of Torrens Title land.

Transfers of Water Access Licences (WALs) and of land held under Old System title will not be affected.

There will be no changes to lodgment fees for transfers of **interests** in land that do not change ownership eg Transfer of Lease, Mortgage or Charge (Form 01TL), Transfer Releasing Easement (Form 01TR).

#### Which Torrens title transfers will be subject to the fee increase?

The lodgment fee for most dealings prepared on Real Property Act (RP) form 01T Transfer will increase to \$184.00 from 1 January 2009. Transfers prepared on some other Real Property Act forms will also be affected by the fee increase.

A table listing all transfers that will attract increased fees is attached.

#### Will all dealings prepared on RP Form 01T Transfer attract the increased fee?

No. The current lodgment fee of \$92.00 will continue to apply to the following dealings prepared on RP Form 01T:

- Transfer by way of Discharge of Mortgage
- Transfer Unilaterally Severing a Joint Tenancy
- Transfer severing a joint tenancy, or changing **tenancy of co-tenants without altering their shares**.

A new form 01DT for Transfers by Way of Discharge of Mortgage will be published on 8 December 2008 on the Lands website [www.lands.nsw.gov.au](http://www.lands.nsw.gov.au).

**Will the new lodgment fee be the same for all affected transfers?**

No. The following transfers already attract a minimum lodgment fee of \$184.00:

- Transfer including covenant (Form 01TCV)
- Transfer including easement (Form 01TE).

From 1 January 2009, the minimum lodgment fee payable for these dealings will be \$276.00.

**Will the new fee apply to any dealing that results in a change to the first schedule of the title?**

No. The new fee will **not** apply to the following dealings that change the first schedule:

**Will the regulations be changed?**

Yes. Mini-budget measures are included in the *State Revenue and Other Legislation Amendment (Budget Measures) Bill 2008*, which was passed by Parliament on Thursday 4 December 2008.

Amendments to the fee schedule of the *Real Property Regulation 2008* appear in Schedule 13 of the Bill. Section 2 of the Bill provides that Schedule 13 will commence on 1 January 2009.
