## Schedule of Land Title Lodgment, Examination and Related Fees - July 2004

The Department of Lands is officially registered in the Australian Business Register and also registered for GST. Its ABN is 21 804 973 362

A new schedule of fees is to operate following gazettal of the:

- Real Property Amendment (Fees) Regulation 2004
- Conveyancing (General) Amendment (Fees) Regulation 2004
- Strata Schemes (Freehold Development) Amendment (Fees) Regulation 2004
- Strata Schemes (Leasehold Development) Amendment (Fees) Regulation 2004.

## Please note that these fees will be effective from Thursday 1 July 2004.

This circular lists fees for most land title related transactions, but it is not comprehensive. Full fee schedules were published in the NSW Government Gazette on 25 June 2004.
