Survey Control Information Management System (SCIMS) products and services

From 1 July 2009, fees for some SCIMS products and services delivered by LPI will increase. Increases are in line with movement in the Consumer Price Index.

SCIMS contains coordinates and related information for survey marks established under the direction of the Surveyor General and is maintained for the purposes of cadastral boundary definition, engineering surveys, mapping and other spatial applications. Customers are encouraged to access SCIMS products online where they are available at lower rates.

The Board of Surveying and Spatial Information is constituted under the *Surveying Act 2002* to provide for the registration of land and mining surveyors, to regulate the making of surveys and to advise the Minister on spatial information. Related fees are set out in Schedule 6 of the *Surveying Regulation 2006*. BOSSI intends to increase fees from 1 July 2009 in line with movement in the Consumer Price Index.
