## Proposed fees for land title related products and services from 1 July 2014

Land and Property Information (LPI) intends to increase fees for land title related products and services from 1 July 2014. Increases will be in line with New South Wales Treasury's forecast for inflation.

## When will the new fees take effect?

The intention is that the new fees will apply from 1 July 2014. LPI expects that regulations relating to the new fees will be published in June 2014 on the NSW legislation website <u>www.legislation.nsw.gov.au</u>.

Current fees will continue to apply until 30 June 2014. Lodgments made before 1 July 2014 but not completed until after that date will be charged at current 2013-14 rates.
