Development of a new online lease folios product

LPI is planning to introduce a new product that will return information about all current lease folios (ie for shops, apartments, etc) in a commercial lease complex. The new product is likely to be called 'Lease Folio Data Extract Report'.

On entry of a Head Lease Title folio identifier, Lease Folio number, or Lease Complex name, information will be returned for every current lease folio in the complex showing:

- Lease Folio number
- Lease number (if there is no current lease on Title, the output will indicate this)
- Description of premises
- Name(s) of lessee(s)
- Date of Registration
- Details of expiry of the lease
- Details of options to renew.

Information will also be supplied regarding any current sub leases, variations of lease, or change of lessee's name. The report can be listed in either lease folio order or premises order, according to the customer's preference.

The inquiry will be made available through all existing delivery channels ie over the counter, through the Lands website, and via Information Brokers. As well as providing a valuable search tool for Lease Folio data, it is expected that the availability of the product will reduce the volume of title searching that LPI's customers need to undertake in relation to Lease Folios.

What will be the cost of the new product?

It is anticipated that the fee charged for the new product will be equivalent to four standard inquiry charges: at current fee rates, the cost will be \$42.00 over the counter, or \$34.00 via the Lands website, inclusive of GST. As a consequence of the introduction of the new product, the cost of a single Lease Folio search will remain unchanged at the standard inquiry fee, currently \$10.50 over the counter and \$8.50 via the Lands website.

What will the new product look like?

Sample Lease Folio Data Extract Report output is attached. It should be noted that this does not necessarily represent the final format, but is indicative of the proposed output.

Why is this new product being developed?

The new product is being developed to respond to the needs of specialist sections of the conveyancing industry that have a particular interest in lease titles. The conversion of Commercial Lease Titles, which commenced in September 2006 as part of a project to convert all manual Torrens Titles to the Integrated Titling System (ITS) has had some unintended consequences for these customers. Following meetings with representatives of the Retail Tenancy Unit, the Real Estate Institute of NSW, the Australia Property Institute, and other interested parties, at which the parties provided information on their business requirements, LPI agreed to develop a new product to meet those requirements.
