When will the new fees take effect?

The new fees will apply from 1 July 2009. Regulations relating to the new fees will be published in June 2009 on the NSW legislation website www.legislation.nsw.gov.au.

Current fees will continue to apply until 30 June 2009, and lodgments made before 1 July 2009 but not completed until after that date will be charged at 2008-09 rates.
