LPI fee changes from 1 July 2011

Land and Property Information, a division of the Department of Finance and Services is officially registered in the Australian Business Register and also registered for GST. Its ABN is 84 104 377 806.

In May 2011 Land and Property Information (LPI) published information about proposed fee increases in LPI Circular 2011/01 and sought feedback from customers. Following the customer consultation period, fee changes have now been finalised.

Details are set out in the attached table.

Are fees for all LPI products and services listed in this circular?

The attached table only lists fees that depend on the commencement of the following regulations on 1 July 2011:

- Real Property Amendment (Fees) Regulation 2011
- Conveyancing (General) Amendment (Fees) Regulation 2011
- Strata Schemes (Freehold Development) Amendment (Fees) Regulation 2011
- Strata Schemes (Leasehold Development) Amendment (Fees) Regulation 2011.

These regulations will be published on the 'Notifications' page of the NSW Legislation website <u>www.legislation.nsw.gov.au</u> before 1 July 2011.

Fees listed in this circular are for products and services involving land titles, property information, land valuations and the Water Access Licence Register.

Are the changes to the fees the same as those proposed in May 2011? Yes.

Are there any transitional arrangements?

2010 fees will be applied to matters such as land title dealings and plans lodged before 1 July 2011 but not finalised until after 1 July 2011.

New product: Multiple purpose production ticket

This new product has been developed in response to customer demand and offers a more efficient option for production of documents in certain cases. The multiple purpose production ticket will enable a certificate of title or other document to be produced once for a period of up to three months, during which time it will be retained by LPI for registration of up to eight separate transactions as listed by customers on the ticket. For example, it will be suitable for use where it is expected that a number of leases of new commercial premises to different parties will be lodged for registration on the same certificate of title at different times over a three month period. Multiple purpose production tickets will be available for purchase from 1 July 2011. A fee of \$84.00 will apply to each ticket.

The multiple purpose production ticket does not replace the existing single purpose production ticket, which remains available at a fee of \$42.00 from 1 July 2011.

New Australian Business number (ABN) for LPI

The LPI division of the Department of Finance and Services is now officially entered in the Australian Business Register under ABN 84 104 377 806. It is registered for GST from 1 July 2011.

Torrens Assurance Levy

Legislation to repeal the Torrens Assurance levy will come into force from 1 July 2011. However, levies will remain payable in relation to some transfers lodged on or after 1 July 2011. See LPI Circular 2011/02 *Real Property Amendment (Torrens Assurance Levy Repeal) Act 2011 No.7* for more information.

An amount of \$4.00 from the lodgment fee for all dealings will be applied to the Torrens Assurance Fund.
